OGALLALA—Whether it's a full-fledged celebration or a low-key community event, there probably will be a party under the new downtown pavilion once it's constructed in the city-owned parking lot between Second and East A Streets. It was recently announced that Ogallala was the recipient of a \$250,000 Civic and Community Center Grant from the Nebraska Department of Economic Development, causing city officials to plan on celebrating the project even sooner. In addition to a new pavilion, city officials are planning an entire uplift project for the downtown area as a result of the grant funding.—reported in the Keith County News.

Crude oil storage site burns in Frontier Co.

CURTIS—Fire on a crude oil storage site in Southwest Frontier county started Monday, April 22, burning and destroying several structures. Members of the Red Willow Rural Fire Department and the Frontier County Sheriff responded to the blaze. The site is owned and operated by Forestar Petroleum of Colorado. It was estimated the fire was possibly started by lightning as there were thunderstorms in the area and no other source of ignition was located.—reported in the Frontier County Enterprise.
